- On February 23, 2023, the reporting person was granted performance stock units (PSUs) that were eligible to be earned based upon the registrant's achievement of specified financial metrics for 2023. One February 19, 2024, the registrant's Compensation Committee determined that the reporting person had earned 10,250 PSUs based on the 2023 financial metrics. Effective on February 19, 2024, 1/3 (or 3,416) of the earned PSUs were deemed vested on December 31, 2023 and an additional 1/3 will vest on each of December 31, 2024 and December 31, 2025, assuming the reporting person continues to be employed by the registrant on each such date.
